DESCRIPTION

Economy and society are not two distinct, separate entities. They are mutually intertwined. Economies necessarily operate within society. Societies inevitably depend on the economy. But can economic and societal values be reconciled? The research traditions of Comparative and International Political Economy (CPE and IPE) seek to answer this question. This course introduces students to the historical lineages, theoretical pluralism, and analytical concerns of CPE and IPE. Students will learn about liberal, realist, Marxist, feminist, and postcolonial research approaches and use them to analyse a range of ongoing political challenges at the intersection of economy and society. For example: Can multinational corporations curb the climate crisis? Can economic sanctions prevent war? Can ethical consumption prevent the exploitation of labour? Can the commodification of care work reduce gender inequality? Can social media influencers be a voice of resistance against the inequality, violence, and injustices of the world economy?

ASSESSMENT

The requirements for active participation are:

- Formal registration
- Reading two key texts per session
- Submiting a visual reflection to the Everyday Archive of the Global Political Economy
- Regular attendance

Everyday Archive of the Global Political Economy: This class introduces various perspectives on the global political economy. This assignment asks you to reflect on how these perspectives can shed light on the impact of the global economy on your everyday life. The last two sessions of the course are designed to create a 'visual reflection' of the global economy based on an activity, object, or situation from your everyday life. The visual reflection must include a picture taken by you and a short text (250-500 words) that explains how the picture illustrates or resonates with the ideas discussed in class. Send the visual reflection to my email (kremers@politik.uni-mainz.de) by 27 January 2024.

Term paper: The paper should be 25 000 characters (+/- 20%), including spaces, and broadly relate to the topic of the course. Please find the formal requirements and marking criteria in Moodle. Deadline for submission is 20 March 2025.

Chatbots: Chatbots based on large language models produce plausible-sounding texts based on statistical probabilities. However, these can be completely wrong in terms of content. Therefore, if you want to use such applications, you need to consider the following:

- Essays are there to examine your academic progress and skills. They must be authored by yourself. Chatbots are therefore not a permissible tool for generating the final draft of your essay.
- Chatbots can, however, be a useful tool for exploring the topic of your essay or even for producing bits of text. Please be alert to the fact that while the texts might sound authoritative, there is nothing on the backend of the technology (other than you) that fact checks the results.
- If you choose to use a chatbot for parts of the essay, add a footnote, explain how you used it, and provide the name of the chatbot and its source (e.g. URL).
